With reference to your application dated 30.6.2012 and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for Senior School Certificate Examination for a period of three years w.e.f. 1.4.2013 to 31.3.2016 in the following subjects:-

(a) Languages:-

English Core, English Elective, Hindi Core, Hindi Elective

(b)

Physics, Chemistry, Biology, Mathematics, Business Studies, Accountancy, Economics, Geography, History, Political Science, Psychology, Home Science, Physical Education and Computer Science

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

"The school will follow syllabi and courses as per scheme of studies prescribed by the Board for 1. Senior School Certificate Examination and changes made therein from time to time."

The school will implement Continuous and Comprehensive Evaluation (CCE) as per the 2

schemes of the Board upto Classes X.

As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, 3. the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.

The school will follow the RTE Act, 2009 and instructions issued thereon by the 4.

CBSE/Respective State Govt./UT.

It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.

The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.

will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.

It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board. 8.

 The school will strictly adhere with all rules regarding safety of students including Fire fighting, Drinking water, Sanitation, Transportation, etc.

14. The school will apply for further Extension of Provisional Affiliation on the prescribed form together with the prescribed fee of ₹ 25,000/- and other essential documents in the preceding year before the expiry of the date.

 The school will open CBSE pattern classes XI w.e.f. 1.4.2013. Accordingly, 1st Batch of class XII of the school will be appearing at the CBSE Examination to be held in 2015.

Other conditions are as per Annexure 'A' enclosed.

17. Special conditions to be complied within three months:-

Every School should organize at least one week training programme for teachers every year in association with any teachers training institute recognized by the State or Central Govt. or by any agency identified by the Board.

 Every institute will provide adequate facilities for potable drinking water and clean healthy and hygienic toilets with washing facilities for boys and girls separately in proportion to the number

of students.

iii) As per suggestions of the Inspection Committee, regular seminars, workshops and orientation programmes to be organized for faculty enrichment.

viv) Number of books in the library is not as per Affiliation Bye-laws. As per norms there should be at

least five books per child in the school library excluding text books, magazines, etc.

The school has maintained the Reserve Fund in an Individual name whereas reserve fund is required to be maintained in the joint names of Manager of the school and Secretary CBSE.

vi) 06 PRTs are not qualified whereas only trained and qualified teachers are required to be

appointed, as per norms.

vii) The school has appointed 13 PRTs and 05 TGTs on adhoc basis whereas appointments are required to be made on regular basis, as per norms.

viii) The school is required to have 03 more TGTs either by fresh appointment or by promoting to existing PRTs to meet the required section teacher ratio 1:1.5 teachers per section, as per present strength.

ix) The deductions of EPF subscriptions are not made from the salary of the staff members. The school is also required to submit copy of Acquittance Roll indicating all emoluments/full details.

x) The school is required to forward a panel of Principals of nearby CBSE affiliated schools including 2-3 of them may be from KV/JNVs, for approval two of them as Board's representatives for inclusion in the School Managing Committee.

Conditions for which compliance to be submitted within three months from the date of issue of sanction letter:-

- Running starting of Class IX/X & XI/XII without prior Provisional Affiliation upto Secondary level/Sr.
  Secondary level from the Board would be unauthorized and school shall be responsible for the
  consequences arising out of it.
- Non-submission of application for extension of provisional affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation Bye-laws.
- School will not prepare any student/start any class for any other Board except CBSE from their CBSE Affiliated school building/premises.
- 4. The Board would not allow any transfer of property/sale of school by one society/ Management/ Trust to another Society/Management/Trust through agreement/sale deed and the school shall not be closed down in the same premises. In case such transaction is effected explicitly or implicitly the Board shall withdraw its affiliation with immediate effect.
- 5. Pay & Allowances to staff should be revised from time to time to bring it at par with that to State Government.
- 6. The service conditions be strictly followed as per State Education Act and Staff be given appointment/confirmation letters etc. accordingly.
- 5-6 names of persons (at least 2-3 from KV/JNV) not below the rank of Principal of Sr. Secondary School
  affiliated with the Board be recommended so that two of them may be approved by the Board as its
  nominee in the School Managing Committee.
- 8. The school shall maintain section teacher ratio at least 1:1.5 at each level i.e. Primary (I-V) Secondary (VI-X) and Sr. Secondary (XI-XII).
